

ODOT SRTS Traffic Gardens Pilot Program Call for Interest

The Oregon Department of Transportation (ODOT) Safe Routes to School (SRTS) program is excited to invite communities to participate in the Traffic Gardens Pilot Program! We are seeking applications from enthusiastic and prepared communities interested in developing traffic gardens to enhance safety education and community engagement.

About the Pilot Program

This pilot offers design and installation services for traffic gardens in Oregon, with the goal of identifying opportunities and challenges for future support of traffic gardens. ODOT SRTS intends to select two non-permanent traffic gardens and one permanent traffic garden during this round of the pilot. Non-permanent gardens will be implemented within the pilot program timeframe, while the permanent garden will focus on detailed design in this phase. This pilot provides design services and installation assistance, including paint or chalk and signs. Applicant will attend 4-6 virtual meetings, one site visit, and will provide local resources such as power washing, wheeled sprayers used for field striping, and installation support. Projects will be selected in February with design and installation in spring 2025 and pilot completion by October 2025.
